

Campus Emergencies Debrief- Residence Hall Association (RHA)- 11.28.18

Please see the below questions and feedback the General Board had at our last meeting. These Minutes were compiled by our RHA Director of Administrative Services and an abbreviated version is published in our Minutes. Please note that the RHA General Board is comprised of 1-3 floor representatives per floor of the 37 floors we have in Student Housing. These representatives are selected by their floor at the beginning of each semester and attached meetings every other week. Below you will see the student and village/floor the inquiry came from in case follow-up is needed.

- **Emergency Evacuation**

- **Zach Anacapa Village B1:** Is there any way that we can have better evacuation plan in place, for getting students off campus more efficiently and orderly. Not feeling safe with evacuation plan for emergency that took place.
- **Nick Anacapa Village B3:** Evacuation pack for each room with emergency supplies and plan on where to meet up after being evacuated. RHA discussed providing feedback to have the evacuation plans/points of important information on the back of every room/suite/apartment door. From a historical sense, we used to have something similar but Tanya was unsure why they were no longer there.
- **Fiona Santa Rosa Village L4 Low:** Shouldn't the campus have more exits for the amount of students we have on campus? Is there plans to build a new exit or open up an emergency exit like what happened on Potrero road? Did the school plan for that opening or did students have to do it?
- **Hailey Santa Rosa Village L4 Low:** Why was the news informed that we were being evacuated before students were informed? I have family and friends calling me and telling me. (source unknown; news delivered about 20 minutes before evacuation announcement was made)
- **Ryan Low Anacapa Village B2:** Loud speaker did not go off in the cafeteria during fire evacuation, and is it possibly to have at least one T.V. on in the cafeteria with the news on so we can know what is going on.
- **Valeria Prado Anacapa Village C3:** Possible training video for evacuation that goes over what we should do during an evacuation? (orientation/town hall meetings/move-in weekend assignment?)

- **Assault incident**

- **Evacuation after assault (Unknown individual)-** Why were we asked to leave classrooms instead of a lock down? It was strange that we were asked to evacuate and the person who was armed could just walk out like anyone else. Tanya did give them the explanation of shelter in place and feedback the police had shared. Students did want an avenue for the police to respond to their concerns.
- **Nicholas Franchi Anacapa Village B3:** Were there any cameras in place to have a better knowledge of who this person was? The description given of the suspect was very vague, making it difficult to understand whom we should be avoiding.

- **Ryan Low Anacapa Village B2:** Would we be able to have a drill for active shooter training?
- **Communication from Housing/ Police**
 - **RHA E-Board:** Notification for both the fire evacuation and assault incidents were delayed.
 - **RHA E-Board:** People were finding out through group chats and GROUPE one hour before the school notified students.
 - **Brittney Marmalejo Town Center A/B:** I called the non-emergency number (3:15 PM) to ask questions about if we had to be evacuated, the operator responded saying you will be notified if you need to be evacuated, but if this is not an emergency I have to go. The student shared they felt that they did not matter and wished for additional detail if they needed to go abruptly.
