## **Undergraduate (Bachelor's) - Affidavit of Financial Support**

F-1 Undergraduate International students are required to provide documentation of financial support before a form I-20 can be issued. If the student will use his/her own personal funds as the source of financial support, the student MUST PROVIDE AN OFFICIAL BANK STATEMENT showing the availability of at least \$42,000 in liquid assets. If the student will be supported by a private sponsor (family member, friend, or private institution) the sponsor must sign the Statement of Financial Obligation below. In addition, sponsors MUST PROVIDE THEIR OFFICIAL BANK STATEMENT showing the availability of at least \$42,000 in liquid assets. Bank statements and financial affidavits cannot be older than 6 months. If the student will be sponsored by a public agency (embassy, home government, public institution, religious organization, etc.), the agency must provide official certification that the costs will be covered. Sponsorship statements cannot be older than 6 months.
