(1) PROVIDE A DESCRIPTION OF THE ACTIVITY

In this workshop participants learned about male survivors of sexual abuse and reviewed skills that enabled insight and effectiveness when working with them. In addition, a screening of the Bristlecone project, a documentary featuring men who had experienced child sexual abuse, was shown.

(2) HOW DID THE ACTIVITY RELATE TO A COURSE(S) AND/OR LEARNING OBJECTIVES?

Child sexual abuse is a global health issue. Much of the literature is done on female child sexual abuse. Students wanting to go into health care need to be aware of the risks of, signs and symptoms of, adult outcomes of, and interventions for male child sexual abuse. This presentation offered an intimate look at the abuse.

(3) WHAT DO YOU SEE AS THE STRENGTHS OF THE ACTIVITY?

The event was well attended by students and the community which demonstrates interest in learning more about the topic. The speaker was excellent. There were approximately 10 community members that attended.

(4) WHAT WOULD YOU SAY ARE/WERE THE ACTIVITY'S WEAKNESSES?

Difficult to say. The event was well attended. We had requested sitting for 70 people and all the chairs were taken. At one point I stood to provide enough seats. Several of the community members didn't realize they had to pay for parking and had to rush to their cars. Next time I will put parking costs on the flyers.

(5) HOW WOULD YOU IMPROVE THIS ACTIVITY FOR NEXT TIME?

I needed more tables and chairs. We had planned for 70 people and every chair was taken. I stood in the back so everyone could sit. One student came in but left because there was no seats. Next time I will order water for attendees and the speaker.

The event could have been advertised longer. It was only posted on campus for about a week prior to the event.

Not to be nervous about students coming or not. Everything went very well. The process went very smoothly! I will apply again for next spring
