The students will collaboratively engage in each others research and discipline. Because of the issues with transportation and the remoteness of the beaches, the group will have to be small. I would like to engage many more students, but the logistics of moving everyone aer complex at this time. If it works out well and we can solve some logistical hurdles, we could increase the numbers in the future.
