Avital component of the learning experience for all PA majors and minors, PA391 addresses the PA Program Learning Outcomes providing students with an opportunity to collaborate with peers from a diverse range of artistic and cultural backgrounds to produce a live stage performance. We will reach out to students across campus, and enrollment by students from other majors is usually high. Description This year Performing Arts will present "Acts & Actos" billed as an evening of short plays in English. Spanish, and Spanglish. The show will include a variety of short plays (6-20 minutes), ranging from actos in the tradition of Luis Valdez's El Teatro Campesino to acclaimed one acts by 20th and 21st century playwrights (6-8 pieces total to make up a 2 hour evening). Hugo Carbajal, an LA-based member of the SF Mme Troupe who visited CI last fall, will return to direct 1-2 of the actos. Laura Covault, a PAlecturer, will direct the one acts and the overall show as the instructor of PA391. The plays staged will depend on the students who enroll in the course, but here are some examples (citations omitted due limited word count, but available upon request): The Moustache by Sabina Berman –"Mexican playwright Sabina Berman's [play] playfully employs a moustache as a traditional symbol of masculinity to ask simple questions about gender equations and morality." Dos Corazones by Richard Hellesen - "written in English and Spanish, where two mothers discover the possibility of hope and understanding through the shared language of motherhood. Antigone's Red by Chiori Myagawa – An adaptation of Sophocles' tragedy "set in a relocation camp in the middle of a desert for Japanese citizens during World War II." Veuve Clicquot by Suzan-Lori Parks - "a play about a condemned prisoner ordering and consuming his last meal under the gaze of a Chorus of Playwriting 101: The Rooftop Lesson by Rich Orloff – "An instructor lectures on playwriting, using two live examples. But after being paused and replayed one too many times, these two characters rise up and revolt against both the instructor and the rules of playwriting itself:" Student participation will include performing on stage before a live audience, assisting the directors and stage manager, researching the Sauderin participation will include performance from the first adulering, sosising the directions and salget inatalogies, researching the performance/production history, coordinating stage costuming and accessories, running the font-of-house, and designing and writing programs and publicity materials, culminating in performances for CI students, faculty, staff, and the general public. During the current budgetary crisis, and in an attempt to reduce overall costs, monies acquired from the IRAwill be used for equipment, independent contractors, and supplies that are essential for the students to carry out their work Learning PA/ART 391 Production. This is the course the cast and crew must enroll in. The learning objectives of PA391 place students at the center of the Outcomes and Relation to IRA to learning experience; they include the development of expertise and practical experience in a production, the evaluation and reflection (in writing) on the creative process, and the application of multiple aspects of performance in production. These goals are accomplished through the collaborative Course Offerings process of preparation and performance central to all performing arts. ART 499 Art Capstone Project. Students will contribute original work as graphic designers and videographers SPAN 320 Introduction to Spanish Translation. Students will assist with translating in order to produce bilingual (English/Spanish) promotional materials and a bilingual program. Depending on the complexity of the scripts selected, they may also translate for super titles on one or more play. SPAN 334 Spanish Language Drama and Theatre. Students may serve as dramaturges as part of a class project, and will study the plays and attend a performance. Other Sources of Funding	The Performing Arts program will cover meals for the cast and crew during long technical rehearsals and strike(breakdown), as well as copier chargebacks and office supply needs. The Art and Performing Arts Program Analyst also tends to put in a significant amount of time tracking purchases and reimbursements for productions like this one, compared to other IRA activities. Also, Catherine Burriss will receive assigned time, funded by the PA program, in order to serve as Producer (coordinating the technical activities outside of rehearsals and event planning). Another source of income for this event is ticket sales, usually \$1000 at minimum.		
Target Audience/Student Marketing	The audience is CI students, the campus community, and the general public. We will promote the performances by announcements in classes, to posters, social media posts, slides on the SUB TV, posters in the larger community, and through personal invites. We hope that the bilingual nature of this particular show will attract new groups of both students and audience members, and we will be designing publicity accordingly (both for the performances in the fall and for auditions and enrollment toward the end of this current semester).
