2. Brief Activity Description

Describe the activity and its relationships to the educational objectives of the students' program or major

Brief Activity Description

This activity involves a field trip to Carrizo Plain National Monument (CPNM), located approximately 150 miles northwest of CI, in southeastern San Luis Obispo County, and protecting approximately 250,000 acres track of land through Presidential Proclamation in 2001. The area within the CPNM contains several unique habitats that are home to sensitive and endangered plant and animal species, and includes Painted Rock, the largest pictograph site in California, a sandstone rock formation approximately 250 long and 45 feet tall decorated with pictographs from Chumash, Salinan and Yokuts peoples who first inhabited the area. In addition to its ecological and historical importance, the conservation of this land was possible through a joint effort between governmental (Bureau of Land Management; California Department of Fish and Game) and non-governmental organizations (i.e., The Nature Conservancy), and renewable and non renewable energy projects (i.e., solar and oil) are located in lands adjacent to CPNM.

The combination of ecological, political, and social circumstances behind the creation of the CPNM create a unique case study through which students learn first-hand how about several human-ecological themes covered in class. Some of these themes include: the links between conservation, nature, and culture; land-use change; social-ecological systems; people and environmental change, political landscape of national lands. This activity also fulfills the course learning outcomes by examining how communities (past and present) adapted to life there, addressing the effects of ecological fluctuations (climate variability) on human populations, and exploring management and conservation programs that are in place.

This field trip spans multiple academic programs, particularly Anthropology and ESRM. However, students from programs such as Biology, History, and Geology may also benefit as the focus of this trip is the nexus between ecological processes, geological formations (e.g., San Andreas Fault), and historical and present day usage of CPNM.

Learning Outcomes and Relation of IRA to Course Offerings

ANTH/ESRM 332 has th following three learning outcomes:

- 1. Describe different models for human adaptations to the environment through time.

- 4. The feedback loops between human communities and ecological systems, including different uses of the area and, more recently, conservation efforts.

Description of Assessment Process

Students are required to submit a "field report" associated to this activity. This report includes their understanding of the uniqueness of the area (historical, ecological, social, political), a personal reflection of the human-ecological interaction found there (e.g., resource use, policy, etc.), and policy suggestions. They are expected to find additional examples of locations where such human-ecological interaction is found, which will be incorporated into their report and discussed in class.

This activity will be the basis for in-depth class discussion on topic such as subsistence strategies, public policy on cultural and environmental resource management. In essence, it will allow students to understand the practical component of the theory discussed prior to and after the activity.
