#### **Brief Activity Description**

Students will be given a unique chance for a detailed view of dissected and preserved human specimens at the Body Worlds: Pulse exhibit at the California Science Center. This powerful experience, has been described as "a convergence of aesthetic anatomy, health and wellness. This special exhibition presents the body in health and distress, its vulnerabilities and potential, and many of the challenges the human body faces as it navigates the 21st Century." Such a three dimensional view will enrich students' understanding of, and respect for, the human body.

### Learning Outcomes and Relation of IRA to Course Offerings

Human Anatomy and Physiology I (BIOL 210) & Human Anatomy and Physiology II (BIOL 211)

In addition to viewing each organ system at the macro and micro perspectives, the current exhibit focuses on the cardiovascular system which will enable an in-depth review for students who have already completed the two semester course sequence, and an impressive preview for those currently enrolled in the course sequence. Students in attendance will be encouraged to develop a robust engagement with the materials in subsequent course modules after viewing these exhibits. Additionally, students will be faced with the ethical issues that accompany posthumous privacy in the pursuit of scientific research and advances.
