2. Brief Activity Description

Brief Activity Description

PLEASE NOTE: this proposal is for the FULL ACADEMIC YEAR (TWO SEMESTERS).

This series of in-class concerts and workshops will bring in high-level professional classical musicians from Finland to CI. The performers are not only world-class artists, they also each have extensive music education experience.

SCHOOL OF EDUCATION (TEACHER EDUCATION AND EARLY CHILDHOOD STUDIES): Our guest artists will perform classical music repertoire in the teacher education program, in the class that focuses on California performing arts standards for (a) elementary school teachers, EDMS 527 "History, Social Studies and Integrated Arts" and (b) for middle, high school, and special education teachers EDSS/SPED 560 "Access to Learning." Music is an important part for children's cognitive development, and emphasized in California Standards for the Teaching Profession; therefore other courses are invited to attend, or integrated to the performers' schedules, but these two are the main courses where performing arts standards are covered. Performers will share pedagogy on how to expose youth who may not have prior experience with classical music, to the world of music. Artists will also share how to integrate music education across curriculum. Performers will also visit an Early Childhood Studies class, "Integrated curriculum" class (ECS 470) which addresses music and the arts while students are student teaching with 4 to 8 year olds.

PERFORMING ARTS: Our guest artists will also perform classical music repertoire also in PAMU 337 "Music In History" course, Music Theory classes, and interdisciplinary "Business and the Performing Arts" (BUS/PAMU 335). Other CI students, faculty, staff, and community members are also welcome to attend these special concerts, and invited through campus emails and OLLI network (Extended Education).

Our fantastic guest artists will demonstrate and discuss significant musical compositions by some of the great Nordic composers, Jean Sibelius, well as contemporary composers such as Einojuhani Rautavaara. In addition, the Romantic, Impressionist, and Modern musical style periods will be represented, giving students a rare up-close view of these masterworks being performed right before their very eyes. The musical selections that are presented by our guest artists correspond directly with the musical style periods and legendary composers that we study in our PAMU337 course.

One concert for this course related performance series involves bringing in a very high-level professional Finnish concert cellist, Jussi Makkonen, whose credits include recitals in some of the main concert halls in Europe and the United States (New York, Los Angeles) and a successful career in music pedagogy. A graduate of the famous Sibelius Academy and an expert of Sibelius, he regularly performs and speaks to international student audiences, including young children. http://jussimakkonen.com/en/ Mr. Makkonen will provide an in-class concert, and a workshop/clinic for ensembles and instrument students. He will also talk about music education and how to bring classical music to students with no prior experience in it.

Kaarlo Hilden is the Dean of the world famous Sibelius Academy, in the music education department that trains music education teachers. He is also an orchestra musician. He will an expert on music pedagogy and teacher education.

Both musicians will be in Los Angeles area on one of the dates indicated and are ready to come to CI (contact has been made already). Other artists who have expressed an interest in coming to CI but whose schedules we still need to confirm (we are not asking for travel but invite them to campus if they are in Los Angeles for other engagements), include Susanna Mälkki (Guest Principal Conductor of LA PHIL); and Anu Komsi (Coloratura soprano, e.g., LA PHIL and Ojai Music Festival). No international travel is requested—these artists have upcoming Los Angeles engagements on their calendars for Spring 2019.

Guest artists will have in-class concerts, workshops, and clinics. There will be time allotted for our students to ask questions of our visiting artists. Past students have overwhelmingly voiced support for these live concert events, and have stated that these concerts are very helpful for them to gain a full understanding of the musical concepts that are presented in coursework.

PAMU 100 (Music appreciation): #1Write about a concert they attend. --This Outcome is also addressed by the writing assignments connected to the performances. [#2 Discuss in writing, musical characteristics and genres of music.] Several Nordic composers will be heard during this concert series. [#3 Differentiate between diverse musical styles of several countries and regions] Students will be exposed to of world music during these performances. {Discuss how Sibelius or Grieg are related to historical, political and cultural events.] Students will be prepped for each concert by the learning the basics of the particular music style during several weeks of classroom meetings.

PAMU337 (Music History): #1: Show, through writing, discussion and oral presentation, an understanding of the course content and convey the key points of this course to an audience of their peers - Students will be required to write a detailed report (analysis &reflection) about the concert/demonstrations, highlighting their observations and informed analysis of the music, based on what have learned in class. #2: Discuss key points in the history of music in the world. -Our guests will discuss the lives and works of the composers whose works they perform. This gives the students a well-rounded historical appreciation for the formation of these musical masterworks, embedded within specific historical time periods.

PAMU308: Ensemble. #1 Perform selected orchestral works using proper intonation and tone quality appropriate to the period and style of each work. #2 Playing tune and blend with all other orchestral instruments. #3 Play with correct articulation and rhythmic precision. Play with correct tone, bowing, and fingering techniques. - The students in our performing ensembles will observe all of the above qualities during these performances.

PAMU 109/309 and PAMU 161, 261, 361, 461 (theory course sequence): These performances will be very enlightening and educational for all PA students who are taking private music lessons at CI. The dedication and extensive training of our professional musical guests is evident in each note that they play. Students will have the opportunity to ask questions of these musical artists during the sessions.

BUS/PAMU 335 (Business and the performing arts): Discuss the business aspects of art and performers. Students will have the opportunity to ask questions of these musicians about their careers and behind-the-scene life (e.g., getting a manager).

Students will complete a survey in class after each event. The results of those surveys will be attached to the post-event report about this IRA event. Student ratings of teachings will be reported as they pertain to student comments on the events.
