## ▼ 2. Brief Activity Description

Describe the activity and its relationships to the educational objectives of the students' program or major

### **Brief Activity Description**

Museums as well as public history are fast becoming alternative employment venues for history majors as well as other students in the humanities and social studies. To critically engage students who are considering a career in museum studies, I am convening a two-day workshop on this topic on the Channel Island Campus in September of 2018. The idea of putting together such a workshop stems from the history department's commitment to the multicultural and international perspective. In addition, to enrich the History Department's experiential and service learning perspective, new classes are currently planned in Museum Studies and Public History. From an international and multicultural perspective, the workshop brings together five experts on the role of museums in the context of the Pacific Islands and Native Americans, the cultures of which have provided great impetus for anthropological, art historical, and historical studies. Four scholars will be traveling from New Zealand (Conal McCarthy), Hawai'i (Ty Tegan), New York (Aaron Glass), and Germany (Philipp Schorch). The last participant of this workshop is the writer of this proposal. The workshop will be divided into two days. The first day, the participants will be visiting two crucial courses associated with the proposed topic: History 380 – History of the Pacific Islands and History 491 Historiography. I will be reaching out to other CI programs (Art History, Anthropology, and Political Science) to encourage them to take advantage of this unique opportunity as well. The day will conclude with a public lecture held in the context of the lecture series Global History and Their Futures. The second day will be a dedicated workshop held in classroom where the participants can share their ideas in a more formal setting. Students will be encouraged to attend this workshop to learn about the intricacies of museum work in an academic setting. The workshop will be publicized in classrooms and around campus to encourage students and faculty to participate.
