### OPENING REMARKS

President Beck welcomed the Council members and introductions were made. The President's Planning and Policy Council (PPPC) is a campus-wide body whose purview is to develop, vet and recommend policy to the President.

### POLICY REVIEW

#### Discussion (1st Reading):

#### **OP.01.007 - Policy on Time, Place and Manner (TPM) and the Use of University Buildings and Grounds**

Nancy Gill started work on this key policy over a year ago with representatives from Student Government, the Dean of Students, Title IX, Human Resources, Conferences & Events, Communication & Marketing (C&M) and Campus Counsel (Marc Mootchnik).

Marc explained that every CSU campus is required to have a TPM policy to respect free speech on campus and not discriminate based upon on the content of the speech.

When drafting this policy, the task force looked at previous policies including (FA.40.005) the Policy on Use of Campus Buildings & Facilities, (CM.02.006) the Policy on Postings & Signage, (SA.07.001) the Policy on Free Speech and Assembly for Students and Title 5 of the California Code of Regulations. Individuals from every Division and specific Departments across campus including the Police Department, Staff Council and the communication roundtable were solicited for review and feedback.

In consultation with the Chancellor's Office Labor and Employee Relations, meet and confers were held with the California Faculty Association (including representatives from CSUCI), California State University Employees Union and the Academic Professionals of California. After much negotiation, this current draft was endorsed. Nancy noted that if any changes or amendments were made to the drafted policy, consultation with the various unions would need to occur.

Nancy walked through the policy noting the accompanying guidelines and approval process.

Helen Alatorre asked if the postings section referred to the miscellaneous bulletin boards on campus. Nancy stated the postings are content-neutral and will not be approved/denied based on their content. Marc added that if the approval process is followed, material must be posted. Any concerns or perceived violations should be reported to C&M.

Helen asked about academic-related postings in the Student Union. Nancy confirmed that postings in the Student Union are controlled by ASI .

Atticus Reyes asked if content mattered. Nancy stated that the content does not matter if the process has been followed. This process is content neutral.

President Beck reminded the Council that, as a public institution, this law will be followed. If anyone sees something that they believe might not have gone through the process, please contact C&M. Virgil Adams asked how long an approved post can stay up; Nancy confirmed two weeks or immediately after the event. Atticus inquired as to who puts the postings up. Nancy indicated that C&M would post for any external group; on-campus groups would post themselves.

President Beck acknowledged the incredible effort and noted tremendous gratitude to those who worked on this policy. A motion to recommend this policy for final approval was made and seconded; policy was approved.
