1. **Introductions-** Joyce Spencer welcomes everyone and thanks you all for joining this meeting

2. **Unfinished Business**

- Earthquake retrofitting – Laboratory equipment, freezers and refrigerators need to be restrained. Follow up with SRIRS if any equipment needs to be restrained.

3. **New Business – Round Table**

- EH&S
 - Generators for power outages – recent outages had no problems with lights or equipment
 - Bunk Beds MEMO - waiting on legal for language for contracting
 - Hazardous and medical waste last pick up for the year in October
 - Fire Extinguisher training in November with Derick and Maggie
 - Mold calls in housing have increased
 - Sandbags for spills are available in Facilities Services
 - EHS inspection reports for laboratories will be sent out
 - Covid-19 update – requirements will be reevaluated in February 2025
 - Mpox – on the rise; retraining for custodians will be scheduled if necessary

- A workorder for fire extinguisher signs in Aliso Hall was made
- Facilities Services (FS)
 - Fire alarms – convert from a fiber loop to individual panels that communicate to dispatch
 - Roxanne Beigel-Coryell fleet manager for the campus
- Grounds
 - Snake sightings – contact PD for rattlesnakes; other snake sightings can go through FS
 - Rodent issues on campus and University Glenn – contact FS for traps
 - Hantavirus information available on EH&S webpage
- Custodians
 - Swallow Nests – nests will be removed and affected areas will be cleaned
 - Bird committee to look at options to deter birds for next year – include student housing
- SRIRS
 - Deferred maintenance
 - Swapped out fire extinguishers – usually every 5 years with a monthly check
 - Safety guard rails for top bunks to be installed
 - Medications in first aid kits in progress
 - Wilderness first aid and fire hose training for staff
 - Purple air monitor that will connect to SRIRS Star link is in progress
- MS Biotech
 - Biohazardous waste will increase this semester due to multiple labs
- HRE
 - Housing population - 1, 044 students
 - Concerns with swallow nests for next year – will work with FS
 - Semester fire evacuation drill was a success
 - Santa Cruz Village regulator scheduled to be replaced in October and will cause a water shut down for a few hours
 - Anacapa boilers concern – Boilers went down for heat last year; will work with FS
 - October 1 – applications will open for Spring Housing
 - Public Safety
 - Anacapa Canyon, Vintage Apartments – increase in medical calls
- CIBC
 - Fire extinguishers on boats – covered by the campus?
 - Sea lion population is more aggressive
