Epinephrine Auto-Injector Training

- 3. Definition and historical purpose: The purpose of this training is to review the applicable polices and protocols for CSUCI PD officer's administration of epinephrine auto-injectors during medical emergencies.
- 4. Justification for the class: CSUCI PD is about to start deploying epinephrine autoinjectors so officers can better treat allergic reactions and anaphylaxis.
- 5. Time Frame: 30 minutes

1. Properly administer an epinephrine auto-injector during an allergic reaction or anaphylaxis.

 - a. Specifically Lexipol Policy 430.10, related to the Administration of Epinephrine Auto-Injectors
- 2. Review Ventura County Emergency Medical Services Policy Number 705.02-Allergic Reaction and Anaphylaxis
 - a. Covers EMS protocol for Allergic Reaction and Anaphylaxis and the administration of epinephrine
- 3. Overview of Epinephrine Auto-Injector Program
 - a. CSUCI PD carries Impax epinephrine auto-injectors, which are one-time use epinephrine auto-injectors. We carry 0.3 mg auto-injectors for patients weighing 30 kg (approx. 66 pounds) and greater and 0.15 mg auto-injectors for patients weighing under 30 kg (approx. 66 pounds).
 - b. Each patrol vehicle EMT bag is equipped with one 0.3 mg epinephrine auto-injector and one 0.15 mg epinephrine auto-injector. The auto-injectors are stored in a small blue Pelican case within the EMT bag.
 - c. During this training, officers will examine an auto-injector and become familiar with it, including reading its instructions.
 - d. The epinephrine auto-injector will be administered by CSUCI PD officers who have received the applicable training provided by AMR and will adhere to Ventura County EMS Policies, Lexipol polices, and the manufacturer guidelines.
 - e. At the beginning of each shift, officers should ensure the epinephrine autoinjector is serviceable and not expired.
 - f. If the epinephrine auto-injector is used or otherwise needs to be replaced the officer should remove the auto-injector from service and immediately email the training sergeant about its status.
