 - a. Into training sessions assembly bill 230 and 392 both of these are in connection with use of force and de escalation
 - i. Agencies are required to have scenario training
 - ii. Sent officers to train the trainer
 - iii. CSUCI will be doing 14 scenarios to our staff
 - iv. Each requires actors and debrief
 - 1. UPAC actor and/or sit in debrief?
