Hello Students,

CSUCI is committed to providing a safe learning and working environment to everyone in the Dolphin community. We do this in a variety of ways - including maintaining compliance with <u>California State</u> <u>University Executive Order (EO) 1095</u>.

As required by EO 1095, all students in the CSU system must participate in a sexual misconduct and interpersonal violence prevention program <u>each academic year in which they are enrolled</u>. The training programs provide information regarding students' rights and safety, confidential University resources, relevant policies, and reporting options.

Please review this information carefully regarding the 2025-2026 requirements below.

## **Everyone (new and returning students)**

All students have been assigned the online 40-minute training entitled "Student Title IX Training - Impressions," which provides information about dating and domestic violence, sexual violence, sexual harassment prevention, bystander intervention, reporting options, and available resources.

All students have 60 days to complete the assignment from the date assigned. You will receive continuous reminders weekly until the assigned program is completed. Students who complete the training before August 25, 2025, will be eligible for incentives offered by the Title IX & Inclusion office.
