# Please read this email in its entirety.

CSUCI is committed to providing a safe learning and working environment to everyone in the Dolphin community. We do this in a variety of ways - including maintaining compliance with California State University Executive Order (EO) 1095.

As required by EO 1095, all students in the CSU system must participate in a sexual misconduct and interpersonal violence prevention program <u>each academic year in which they are enrolled</u>. The training programs provide information regarding students' rights and safety, confidential University resources, relevant policies, and reporting options.

Please review this information carefully regarding the 2024-2025 requirements below.

#### Newly enrolled Fall 2024 undergraduate students

These students have been assigned the online 60-minute program entitled "Sexual Violence Prevention," which provides information about sexual violence prevention and the definitions of consent, sexual assault, rape, domestic violence, and stalking.

### Returning and graduate students

These students have been assigned a 25-minute refresher version entitled "Clarifying Consent" of this program which focuses further on sexual harassment and stalking.

# **Everyone (new and returning students)**

All students must complete their assigned program by Oct. 17, 2024. You will see a hold on your student account on Oct. 18, 2024, if you do not complete the assigned program on time. This hold will prevent you from registering for classes for Spring 2025 until the program is completed.

### Accessing the training

Both programs provide information regarding students' rights and safety, confidential University resources, and relevant policies and reporting options. Note that survivor stories are included in the modules to broaden campus understanding about the impact of sexual misconduct and

gender-based violence in our community and beyond, but there are no graphic representations.
